PROGRAM REQUIREMENTS

Admission: Students are required to pay for at least one lesson per week on a monthly basis. Ages 7 years and up. For younger riders age requirements may change depending on the time of year and availability of arenas. Lessons are based on one rider and are not transferable. Admission is also based on rider's physical condition including weight.

Registration: Applications are accepted on an on going basis. Payment is due when the application is submitted. After the first series, payment is due by the 20th of the preceding service month. Payments received after the 20th are subject to additional charges, as well as, the risk of losing previously reserved time slot. Lessons must be paid for before given. The registration period ends the date of the last paid lesson.

Equipment: Long sturdy pants and boots with a heel. As the rider progresses, recommendations will be given regarding the purchase of other riding apparel and equipment. English riding boots, a helmet, and appropriate hair wear are required after the first series of lessons. Non-riders should also wear shoes and clothing appropriate for this environment.

Time: Allow about an hour and a half for lessons. Lessons include ground school before and after the mounted portion of the lesson. Non mounted classes will be given as required. The arrival time for ground school is 1/2 hour prior to the area time. A minimum of a 24 hour notice based on the arrival time if required to reschedule lessons.

Supervision: A parent or guardian must stay with minor riders (unless prior arrangements have been made with the office) and are responsible for other family members and guests. Pets are not allowed on the property.

Privileges: Stable privileges are applicable during scheduled lesson time only.

Cancellations: Any notice less than 24 hours is recorded as a same day cancellation and will be forfeited. We cannot make exceptions or special arrangements for unforeseen circumstances. Lessons that fall on holidays, horse shows or poor weather conditions can be rescheduled within the "Make up lessons" guideline listed below. Springbrook does not cancel lessons because of school closings and will contact riders or riders family if lessons are going to be canceled.

Make up lessons: will be provided only when the lesson is cancelled at least twenty-four (24) hours prior to the scheduled arrival time. All canceled lessons must be made up within two weeks of the missed lesson and within the registration period. The registration period ends the date of the last paid lesson. Refunds may be given in cases of withdrawal from the program due to illness or injury, a refund of 50% will be given with a doctor's note if more than one consecutive lesson has been missed due to the illness or injury providing notice has been given for each cancellation (otherwise refunds are not given).
